- 2. **National Night Out** Event set for August 6 in lower South Shores Cul-de-Sac (2233 WARMOUTH) following the same format has in August 2023. Flyers are being distributed.
- 3. **JULY 4 BLOCK PARTY** The Board commended Bob Chiurzzi, who chaired the successful event. There is interest in scheduling a similar event in October in the same location.
- 4. **Speed Bumps** An application will be submitted when the city dates are announced.
